Over 200 attend SMF Health/Wellness Expo 2004

The USAID funded 2004 Health expo, hosted by the Stella Maris Foundation for the people of Grant's Pen was indeed a success. The theme 'wellness for life mind, body and spirit' was expounded upon by Dr. Annette Alexis who reminded the residents that "this is not a health fair where we have doctors checking up people, but rather we are seeking to empower the residents of the community with knowledge by giving them information that they can use to better their lives".

Over two hundred residents turned out for the event. The Fair was realized on a budget of approximately \$100,000.00. Fish Medical, The Diabetic Association of Jamaica, The Cancer Society of Jamaica, The Ministry of Health:Behaviour Modification and Mental Health unit, PERF, Nestle Jamaica, The National Insurance Scheme, The National Health Fund, St. Joseph's Hospital, Ted Emmanuel, PATH, Health Associates, Symmetry, as well as Tony Williamson in conjunction with the

Strengthening Families for a Stronger Community

The Foundation recognizes the importance of parenting and family relations as it relates to socio-economic issues locally and internationally. In an attempt to stimulate a community response to these issues in Grant's Pen, a collaborative effort is undertaken with Parenting Partners to discuss progress of their manual revision. Further, SMF Community Officers attended a three-day workshop to undergo training as parenting facilitators. A list of parents in the mentorship programme at the Shortwood Practicing was obtained and contact made to invite them to be a part of focus groups/training. A second list was formed comprising parents from the Grant's Pen Community for a second focus group.

As part of the Community empowerment Project, Plans are afoot to form a **Women's Group**.

The Police Executive Research Forum (PERF) chaired the Domestic Violence Work Group meeting held on May 20, 2004. This meeting was called to discuss the way forward with all the stakeholders at the table. It was agreed that monthly meetings were sufficient to discuss progress and issues related to Domestic Violence sensitization.
